

## 407 International Reports 2018 Results

**TORONTO, February 7, 2019** - 407 International Inc. (the "Company") announced today revenues of \$1,390.3 million for the year ended December 31, 2018, compared to \$1,267.7 million for 2017. Earnings before interest, taxes, depreciation and amortization ("EBITDA"<sup>1</sup>) totalled \$ 1,210.6 million for 2018 as compared with \$1,103.8 million for 2017. The Company reported net income of \$539.0 million for 2018, compared with net income of \$470.1 million for 2017.

The Board of Directors declared an eligible dividend of \$0.323 per common share, payable on or about February 7, 2019 to shareholders of record on February 7, 2019.

The Company is owned by Cintra Global S.E., a wholly owned subsidiary of Ferrovial S. A. (43.23%), by indirectly owned subsidiaries of Canada Pension Plan Investment Board (total 40%), and by SNC-Lavalin (16.77%).
